- MAP Year 1 Data fit bell curve closely. Goals to be in 80%, versus 73-79%
- CMAS Math and English performance results Leman versus DCSD
- No comments on results
- School Performance Plan/Framework
 - Middle School handful of 6th graders that performed tests
 - Amount of 7th and 8th grade scholars didn't qualify for testing because of amounts
 - Elementary Academic Achievements (meets) and Academic Growth (Exceeds)
 - Cumulative score is 71.3/100
 - Low participation –
 - School/District/State results
 - Why do parents opt out?
 - o Difficult for some scholars too stressful
 - "Doesn't really matter"
 - Anxiety around testing
 - o Parents believe that there is too much testing
 - Lack of knowledge for school need to educate parent population
 - Middle School contradicted what Leman's goal is.
 - Testing "Myth Busters" around testing time
 - Share Leman's Testing Q&A on website
 - Why are scholars' test results lower in upper grade levels?
 - Setting culture with tight knit community and then results will come
 - · Identity crisis with middle schoolers
 - "I'm bad at English or Math" mind set, clinical approach with Scholar Hours
 - Scholars are coming in with different curriculum background, compounds over time
 - o What would parents like to know?
 - Hodgepodge of schools combining into Middle School
 - Mixture of former curriculums will "level off" and anxiety will decrease
 - Comfortable in a testing environment
 - History curriculum and freedom and ability to think critically and writing skills
 - Messaging of state test to students and parents unified approach
 - Longevity and retention of Scholars grow from the bottom up, strategic approach on class size
 - What resources or allocations should be done for teachers?
 - Building up resources and curriculum
