CMAS	Colorado Measures of Academic Success Colorado Measures of Academic Success (CMAS) are the system of statewide tests in English language arts, math, science and social studies that are given to all Colorado students in grades three through high school. Resource: CDE CMAS	
CoAlt	Colorado Alternate English Language Arts and Math The Colorado Alternate (CoAlt) Assessment is an academic, standards-based assessment designed specifically for eligible students with the most significant cognitive disabilities. The primary purpose of the assessment program is to determine the level at which Colorado students with the most significant cognitive disabilities meet the Extended Evidence Outcomes (EEOs) of the Colorado Academic Standards. CSLA	Colorado Spanish Language Arts Colorado Spanish Language Arts, is an accommodated version of the CMAS (Colorado Measures of Academic Success) English Language Arts (ELA) assessment. It's available for eligible Spanish-speaking students in grades 3 and 4 who are taking ELA. The CSLA assessment is designed to provide a more accessible means for students to demonstrate their knowledge and skills in language arts.	
PSAT 9, PSAT 10	Preliminary SAT/National Merit Scholarship Qualifying Test ■ The PSAT 9 and PSAT 10 is a standardized test designed to assess students' skills in reading, writing, and mathematics, serving as a stepping stone to the SAT and a qualifying test for the National Merit Scholarship Program. It's administered by the College Board and the National Merit Scholarship Corporation. SAT	Scholastic Aptitude Test, formerly Scholastic Assessment Test The SAT is a standardized test used in the United States and many other countries to assess the readiness of high school students for college-level work.
